

Haddam Little League Sponsorship Agreement 2010

This agreement between the Haddam Little League (hereinafter, "Local Little League") and _____ (hereinafter, "Sponsor") is for the 2010 season.

Sponsorship of a team in the Local Little League must be, for the Sponsor, out of a sense of duty to help the community. While Sponsorship does afford some benefits (detailed below), the higher purpose is to help the Local Little League impart the values of teamwork, sportsmanship, and fair play to the children of the community, so that they may someday use these values in becoming good citizens.

Sponsorship of a team in the Local Little League does not permit the Sponsor to have any rights or responsibilities in the operation of the Local Little League or any team in the Local Little League, nor does the Sponsor have any rights or responsibilities in the selection of managers, coaches or players for any team in the Local Little League. Nothing herein shall make us partners or this agreement a joint venture. The Sponsor and the Local Little League are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein.

For the considerations above, the Sponsor donates \$200.00 to Haddam Little League, understanding that its donation is to benefit the entire league.

The Sponsor shall have the right to use the following term in advertisements, posters, brochures, newsletters, etc.: "Sponsor of a team in the Haddam Little League." Sponsorship does NOT give the Sponsor the right to use the word "official" in connection with its Sponsorship. Any reference to the Sponsorship under this agreement must make it clear that the Sponsorship is with a team or teams in the Haddam Little League only, and NOT for Little League Baseball and softball. Use of the "keystone logo" or any other logo of Little League Baseball and Softball is prohibited, unless permission is expressly granted in writing by Little League International. Sponsorship in the Local Little League carries with it the following additional benefits:

- **Name of Business on Jersey and/or hat**
- **Recognition Plaque with team photo for the 2010 season**
- **Recognition at Jail Hill Ball Field Concession Stand on sponsor board**
- **Listed on the Haddam Little League Website (haddamlittleleague.org)**
- **Opportunity to have a link or email displayed on our Links tab**

Payments of fees to the Haddam Little League are due by February 28, 2010. Please remit your payment with a signed copy of this agreement by the due date to insure jerseys/hats are ordered in time for our season.
